**ORDINANCE 15-2008**

AN ORDINANCE AMENDING THE CONTRACT WITH TWINSBURG FIRE FIGHTERS LOCAL 3630 INTERNATIONAL ASSOCIATION OF FIRE FIGHTERS, AND DECLARING AN EMERGENCY

---

**WHEREAS**, the Administration conducted extensive negotiations with Twinsburg Fire Fighters Local 3630 International Association of Fire Fighters, as the bargaining representative for the Fire Fighters; and

**WHEREAS**, such negotiations resulted in the entering of an Agreement between the parties effective January 1, 2006 through December 31, 2008, as authorized by way of Ordinance 72-2006; and

**WHEREAS**, Council and the Administration have determined that it is in the best interests of the City of Twinsburg to amend the final year of the Agreement.

**NOW, THEREFORE, BE IT ORDAINED** by the Council of the City of Twinsburg, County of Summit and State of Ohio:

**SECTION I:** That effective January 1, 2008 the Agreement between the City of Twinsburg and Twinsburg Fire Fighters Local 3630 International Association of Fire Fighters shall hereby be amended as follows:

Wages as set forth in "Appendix A" to the Agreement shall be amended to reflect that the employees shall be compensated at a 3.5% higher rate over year ending 2007 as compared to the 3% currently reflected in the Agreement.

**SECTION II:** It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were taken in open meeting or meetings of this Council, and that all deliberations of this Council were in meetings open to the public and in full compliance with all legal requirements, including without limitations, those set forth in Section 121.22 of the Ohio Revised Code.

**SECTION III:** That this Ordinance is hereby declared to be an emergency measure, necessary for the immediate preservation of the public peace, health, safety welfare and convenience of the citizens of the City of Twinsburg, and for the additional reason that in order to facilitate payment of compensation to certain employees of the City, the foregoing ordinance is required at the earliest possible time, and provided it receives the affirmative vote of five or more members of Council, it shall take effect and be in force immediately upon its passage and approval of the Mayor; otherwise, it shall take effect and be in force at the earliest period allowed by law.
