RESOLUTION 29-2008

A RESOLUTION EARMARKING PARTIAL FUNDING FROM THE SALE OF EXCESS PROPERTY TO THE MULTIPURPOSE TRAIL PROJECT AS SET FORTH IN ORDINANCE 150-2007; AND DECLARING AN EMERGENCY.

WHEREAS, Ordinance 150-2007 is currently before Council authorizing funding for a multipurpose trail project; and

WHEREAS, the City will receive partial funding for this project through a grant; and

WHEREAS, the City has certain property located south of Locust Grove Cemetery for sale (hereafter the "Property") and it is the Council's desire that any funds received from the sale of the Property be earmarked specifically for partial funding of the balance of the City's financial obligation for the multipurpose trial project.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Twinsburg, State of Ohio:

SECTION 1. That any proceeds received from the sale of the Property as set forth herein be applied to the balance of the City of Twinsburg's financial obligation for the Multipurpose Trial Project.

SECTION 2. That it is hereby found and determined that all formal actions of the Council concerning and relating to the passage of this Resolution were taken in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were meeting open to the public and in compliance with the law.

SECTION 3. This Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety convenience and welfare of the City of Twinsburg and the inhabitants thereof, and for further reason that the source of funding of the project is important in order to properly evaluate the City's financial landscape, and provided that it receives the approval of two-thirds of the members of Council, shall be in full force and effect from and after its passage and approval; otherwise to be in full force and effect from and after the earliest period allowed by law.
