RESOLUTION 03-2008

**A RESOLUTION APPOINTING THREE MEMBERS TO
THE ARCHITECTURAL REVIEW BOARD AND
DECLARING AN EMERGENCY**

WHEREAS, Section 1321.03 of the Codified Ordinances of the City of Twinsburg provides that the Architectural Review Board shall consist of three residents of the Municipality holding no other public office in this Municipality, who shall be appointed by a majority vote of all the members of Council; and

WHEREAS, the term of office of three members expired on January 31, 2008; and

WHEREAS, it is now incumbent upon this Council to appoint three members of said Board to fill such resulting vacancies upon said Board.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Twinsburg, County of Summit and State of Ohio:

SECTION I: That the following named residents of the City of Twinsburg not holding any other municipal office or appointment be, and the same hereby are, appointed as a member of the Architectural Review Board to fill the term as the same appears below:

SECTION II: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were taken in open meeting or meetings of this Council, and that all deliberations of this Council were in meetings open to the public and in full compliance with all legal requirements, including without limitations, those set forth in Section 121.22 of the Ohio Revised Code.

SECTION III: That this Resolution is hereby declared to be an emergency measure, necessary for the immediate preservation of the public peace, health, safety welfare and convenience of the citizens of the City of Twinsburg, and for the additional reason to fill the vacancies prior to February 1, 2008, and provided it receives the

affirmative vote of five or more members of Council, it shall take effect and be in force immediately upon its passage and approval of the Mayor; otherwise, it shall take effect and be in force at the earliest period allowed by law.
