AN ORDINANCE AMENDING CHAPTER 913 OF THE  
CODIFIED ORDINANCES OF THE CITY OF  
TWINSBURG AMENDING THE SEWER USE  
REGULATIONS

**WHEREAS**, the Public Works Department has proposed recommendations to Chapter 913 of the Codified Ordinances of the City of Twinsburg regulating Sewers in the City of Twinsburg, Ohio; and

**WHEREAS**, the proposed amendments are designed to comply with the Ohio EPA regulations and are intended to streamline and update the current language of Chapter 913; and

**WHEREAS**, Council has determined that it is in the best interests of the City of Twinsburg and its residents to adopt the amendments as proposed.

**NOW, THEREFORE, BE IT ORDAINED** by the Council of the City of Twinsburg, County of Summit and State of Ohio:

**SECTION I:** That Section 913 of the Codified Ordinances of the City of Twinsburg is hereby be amended and adopted in full as reflected in the attached **Exhibit A** which is incorporated herein and adopted hereto as if fully rewritten.

**SECTION II:** It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were taken in an open meeting or meetings of this Council and any of its committees that resulted in such formal action, were in meetings open to the public and in full compliance with all legal requirements, including without limitations, those set forth in Section 121.22 of the Ohio Revised Code.

**SECTION III:** That this Ordinance shall take effect and be in force from and after the earliest period allowed by law.
