ORDINANCE 14-2009

AN ORDINANCE AUTHORIZING THE MAYOR TO EXECUTE A DEED OF CONSERVATION EASEMENT GRANTING UNTO THE SUMMIT SOIL AND WATER CONSERVATION DISTRICT A CONSERVATION EASEMENT TO BE IN COMPLIANCE WITH ARMY CORP PERMIT 97-512-0048 ISSUED FOR OFFICER JOSHUA T. MIKTARIAN PARKWAY CONSTRUCTION

WHEREAS, the City of Twinsburg is the owner of a certain parcel of land consisting of 7.40 acres more or less located west of Darrow Road and north of Officer Joshua T. Miktarian Parkway

WHEREAS, said property was proposed to be used as mitigation in the application to the Army Corp for permit to construct Officer Joshua T. Miktarian Parkway and made part of permit 97-512-0048 issued to the City

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Twinsburg, County of Summit and State of Ohio:

SECTION I: That the Mayor of the City of Twinsburg be and he is hereby authorized to execute a Deed of Conservation Easement conveying unto the Summit Soil and Water Conservation District and its assigns an interest and conservation easement in certain real property consisting of 7.40 acres more or less located west of Darrow Road and north of Officer Joshua T. Miktarian Parkway in Twinsburg, Ohio, as more fully described in the Exhibits incorporated into said agreement which agreement is attached hereto and incorporated by reference herein and identified as Exhibit "B".

SECTION II: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were taken in open meeting or meetings of this Council, and that all deliberations of this Council were in meetings open to the public and in full compliance with all legal requirements, including without limitations, those set forth in Section 121.22 of the Ohio Revised Code.

SECTION III: That this Ordinance shall take effect and be in force from and after the earliest period allowed by law.
