ORDINANCE 20-2009

AN ORDINANCE AMENDING SECTION 147.01 OF
CHAPTER 147 "EMPLOYEE CLASSIFICATIONS" OF
THE CODIFIED ORDINANCES OF THE CITY OF
TWINSBURG AND DECLARING AN EMERGENCY

WHEREAS, the Administration has recommended an amendment to Section 147.01 of Chapter 147 of the Codified Ordinances of the City of Twinsburg; and

WHEREAS, Council recognizes that the recommended amendment is necessary for the continued efficient operation of the City.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Twinsburg, County of Summit and State of Ohio:

SECTION I: That Section 147.01 is hereby amended to read as follows:

147.01 EMPLOYEE CLASSIFICATIONS

- (a) Full Time Employees, (including Department Heads)
- (1) Work standard 40 hour workweek (except Fire Captains in shift rotations),
 - (2) All are Non-exempt (eligible for overtime) except Department Head, (which includes Chief of Fire, Chief of Police, Director of Community Planning and Development, Director of Finance, Director of Human Resources, Director of Parks and Recreation, Director of Public Works, Golf Course Manager, and Golf Course Superintendent) and Senior Network Administrator, Building Commissioner, Municipal Engineer, Police Lieutenant, Assistant Fire Chief, General Superintendent in Service Division, Wastewater Treatment Superintendent, Center Manager in Fitness Center, and Working Forman in Parks Division.
 - (3) ~~Department Heads may accrue and use compensatory time, after 40 hrs per week with permission Mayor, but will not be eligible for a cash payout comp time.~~
 - (3) Hours of work may vary by department

SECTION II: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were taken in open meeting or meetings of this Council, and that all deliberations of this Council were in meetings open to the public and in full compliance with all legal requirements, including without limitations, those set forth in Section 121.22 of the Ohio Revised Code.

SECTION III: That this Ordinance is hereby declared to be an emergency measure, necessary for the immediate preservation of the public peace, health, safety, welfare and convenience of the citizens of the City of Twinsburg, and for the additional reason that it is the need of the community, and provided it receives the affirmative vote of five or more members of Council, it shall take effect and be in force immediately upon its passage and approval of the Mayor; otherwise, it shall take effect and be in force at the earliest period allowed by law.
