ORDINANCE 37-2009

AN ORDINANCE AUTHORIZING THE MAYOR TO ENTER INTO AN AGREEMENT WITH PERRY & ASSOCIATES, CERTIFIED PUBLIC ACCOUNTANTS, FOR THE FURNISHING OF PROFESSIONAL SERVICES TO PROVIDE FOR THE AUDIT OF THE FINANCIAL STATEMENTS FOR THE YEAR ENDING DECEMBER 31, 2008 AND DECLARING AN EMERGENCY

WHEREAS, the professional auditing services bid process was conducted on behalf of Twinsburg through the Ohio State Auditor Mary Taylor's office; and

WHEREAS, this independent public accounting firm was selected and awarded by Mary Taylor, CPA Auditor of State of Ohio and an agreement has been entered into between the State Auditor of Ohio, Perry & Associates, CPA's A.C., and the City of Twinsburg on January 6, 2009.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Twinsburg, County of Summit and State of Ohio:

SECTION I: That the Mayor be and she hereby is, authorized and directed to enter into an agreement with Perry & Associates Certified Public Accountants, Cleveland, Ohio, to conduct an audit for the total fiscal period of January 1, 2008 through December 31, 2011. This contractual fee is not to exceed ONE HUNDRED TWENTY SEVEN THOUSAND, SIX HUNDRED DOLLARS AND ZERO CENTS (\$127,600.00) "Exhibit A".

SECTION II: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were taken in an open meeting or meetings of this Council and any of its committees that resulted in such formal action, were in meetings open to the public and in full compliance with all legal requirements, including without limitations, those set forth in Section 121.22 of the Ohio Revised Code.

SECTION III: That this Ordinance is hereby declared to be an emergency measure, necessary for the immediate preservation of the public peace, health, safety welfare and convenience of the citizens of the City of Twinsburg, and for the additional reason to allow the Auditor enough time to perform said service in order to meet the deadline mandated by the Ohio State Auditor. Provided it receives the affirmative vote of five or more members of Council, it shall take effect and be in force immediately upon its passage and approval of the Mayor; otherwise, it shall take effect and be in force at the earliest period allowed by law.
