ORDINANCE 38-2010

AN ORDINANCE AUTHORIZING THE LEASE OF SIX (6) 2010 DODGE CHARGER VEHICLES THROUGH GOLLINGS ARENA CHRYSLER, JEEP & DODGE, FOR USE BY POLICE DEPARTMENT OF THE CITY OF TWINSBURG

WHEREAS, the purchase of certain equipment through said office is in compliance with the provisions of the Charter of the City of Twinsburg relative to competitive bidding; and

WHEREAS, the Capital Improvement Board has approved of the leasing of the vehicles for the Police Department; and

WHEREAS, Council is advised by the Chief of Police that it is necessary to have these additional police cruisers for use by the police department.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Twinsburg, County of Summit and State of Ohio:

SECTION I: That the Mayor is hereby authorized enter a three (3) year lease through Gollings Arena Chrysler, Jeep & Dodge, six (6) vehicles at a total cost not to exceed the amount of ONE HUNDRED SIXTY FOUR THOUSAND, EIGHT HUNDRED AND SIXTY TWO DOLLARS (\$164,862.00).

SECTION II: That the Director of Finance is hereby authorized to disburse the funds necessary to meet the lease obligations from account number 82-000-5252-07 Capital Police Equipment, for the years of 2010 through 2012.

SECTION III: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were taken in open meeting or meetings of this Council, and that all deliberations of this Council were in meetings open to the public and in full compliance with all legal requirements, including without limitations, those set forth in Section 121.22 of the Ohio Revised Code.
