RESOLUTION 11-2010

A RESOLUTION ALLOWING THE MAYOR TO APPLY FOR FEDERAL SURFACE TRANSPORTATION PROGRAM (STP) RESURFACING FUNDS PROGRAMMED BY THE AKRON METROPOLITAN AREA TRANSPORTATION STUDY (AMATS) TO IMPROVE RAVENNA ROAD AND DECLARING AN EMERGENCY

WHEREAS, Ravenna Road is a minor arterial; and

WHEREAS, this road serves the community and is integral to the transportation network to the City of Twinsburg; and

WHEREAS, Ravenna Road is in need of Resurfacing.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Twinsburg, County of Summit and State of Ohio:

SECTION I: That the Mayor is hereby authorized to apply for Federal Surface Transportation Program (STP) Resurfacing Funds programmed by the Akron Metropolitan Area Transportation Study (AMATS) for the following Resurfacing Project:

(1) Ravenna Road Resurfacing from SR91 to East Idlewood Drive and from Chamberlin Road to Northern Corp Limit; at an Estimated Cost of \$882,000.

SECTION II: That the City of Twinsburg acknowledges and understands the AMATS “Funding Policy Guidelines” and confirms to the best of its knowledge that the information contained in the project application is accurate, that it intends to diligently pursue that project, and that a local share is required to match federal funds.

SECTION III: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were taken in open meeting or meetings of this Council, and that all deliberations of this Council were in meetings open to the public and in full compliance with all legal requirements, including without limitations, those set forth in Section 121.22 of the Ohio Revised Code.

SECTION IV: This Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety convenience and welfare of the City of Twinsburg and the inhabitants thereof, for the reason that it is to apply for this funding within the next six days, and provided that it receives the approval of two-thirds of the members of Council, shall be in full force and effect from and after its passage and approval; otherwise to be in full force and effect from and after the earliest period allowed by law.
