RESOLUTION 15-2010

A RESOLUTION APPOINTING THREE MEMBERS TO THE PARKS AND RECREATION COMMISSION, AND DECLARING AN EMERGENCY

WHEREAS, Section 143.01(a) of the Codified Ordinances of the City of Twinsburg provides that the Parks & Recreation Commission shall be comprised of seven inhabitants of the City; and

WHEREAS, said Section further provides that each ward shall be represented by an adult member; and

WHEREAS, the term of three (3) adult members expires on January 31, 2010; and

WHEREAS, it is now incumbent upon this Council to appoint (3) three members of said Commission to fill such vacancies.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Twinsburg, County of Summit and State of Ohio:

SECTION I: That the following named inhabitants of the City of Twinsburg not holding any other municipal office or appointment be and the same hereby are, appointed as members of the Twinsburg City Parks and Recreation Commission for the term as the same appears below:

1. Joe Zeitz	3	2-1-10 through 1-31-12
2. David Post	4	2-1-10 through 1-31-12
3. David Kleinman	5	2-1-10 through 1-31-12

SECTION II: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were taken in open meeting or meetings of this Council, and that all deliberations of this Council were in meetings open to the public and in full compliance with all legal requirements, including without limitations, those set forth in Section 121.22 of the Ohio Revised Code.

SECTION III: That this Resolution is hereby declared to be an emergency measure, necessary for the immediate preservation of the public peace, health, safety welfare and convenience of the citizens of the City of Twinsburg, and for the additional reason to fill these vacancies prior to February 1, 2010, and provided it receives the affirmative vote of five or more members of Council, it shall take effect and be in force immediately upon its passage and approval of the Mayor; otherwise, it shall take effect and be in force at the earliest period allowed by law.
