**RESOLUTION 26-2009**

**A RESOLUTION APPOINTING THREE MEMBERS TO  
THE BEAUTIFICATION COMMISSION AND  
DECLARING AN EMERGENCY**

**WHEREAS**, Section 153.01 of the Codified Ordinances of the City of Twinsburg provides that the Beautification Commission shall consist of five members who are residents and shall be appointed by a majority vote of all the members of Council; and

**WHEREAS**, the term of two members of said Board expired as of November 30, 2008; and

**WHEREAS**, it is incumbent upon Council to appoint (3) three members to fill such resulting vacancies upon said Commission.

**NOW, THEREFORE, BE IT RESOLVED** by the Council of the City of Twinsburg, County of Summit and State of Ohio:

**SECTION I:** That the following named residents of the City of Twinsburg, are appointed as members of the Beautification Commission to fill the term as the same appears below:

**SECTION II:** It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were taken in open meeting or meetings of this Council, and that all deliberations of this Council were in meetings open to the public and in full compliance with all legal requirements, including without limitations, those set forth in Section 121.22 of the Ohio Revised Code.

**SECTION III:** That this Resolution is hereby declared to be an emergency measure, necessary for the immediate preservation of the public peace, health, safety welfare and convenience of the citizens of the City of Twinsburg, and for the additional reason to fill the vacancies prior to February 1, 2009, and provided it receives the affirmative vote of five or more members of Council, it shall take effect and be in force

immediately upon its passage and approval of the Mayor; otherwise, it shall take effect and be in force at the earliest period allowed by law.
