RESOLUTION 29-2009

**A RESOLUTION APPOINTING THREE RESIDENT
MEMBERS TO THE GLENEAGLES ADVISORY
BOARD AND DECLARING AN EMERGENCY**

WHEREAS, Section 155.02 of the Codified Ordinances of the City of Twinsburg provides that the GlenEagles Advisory Board shall include five (5) residents of the City; and

WHEREAS, the term of office of three members expires January 31, 2009; and

WHEREAS, it is incumbent upon this Council to appoint three (3) members to said Board.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Twinsburg, County of Summit and State of Ohio:

SECTION I: That the following named inhabitants of the City of Twinsburg be and the same hereby is appointed as members of the GlenEagles Advisory Board for the term as the same appears below:

SECTION II: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were taken in open meeting or meetings of this Council, and that all deliberations of this Council were in meetings open to the public and in full compliance with all legal requirements, including without limitations, those set forth in Section 121.22 of the Ohio Revised Code.

SECTION III: That this Resolution is hereby declared to be an emergency measure, necessary for the immediate preservation of the public peace, health, safety welfare and convenience of the citizens of the City of Twinsburg, and for the additional reason to fill the vacancies prior to February 1, 2009, and provided it receives the affirmative vote of five or more members of Council, it shall take effect and be in force immediately upon its passage and approval of the Mayor; otherwise, it shall take effect and be in force at the earliest period allowed by law.
