RESOLUTION 29-2010

A RESOLUTION AMENDING THE TWINSBURG OCCUPANCY PROGRAM, AGREEMENT WITH VERIZON WIRELESS TO CHANGE NAME TO INCLUDE CELLCO PARTNERSHIP d/b/a VERIZON WIRELESS AND AFFILIATES

WHEREAS, the City of Twinsburg, by Resolution 144-2004 has established the Twinsburg Occupancy Program Ordinance pursuant to Chapter 3735 of the Ohio Revised Code; and

WHEREAS, Verizon Wireless has made application and been granted tax incentives under the Twinsburg Occupancy Program pursuant to Resolution 165-2009; and

WHEREAS, Verizon Wireless has requested an amendment to the Agreement to state Cellco Partnership d/b/a Verizon Wireless and Affiliates; and

WHEREAS, Verizon Wireless has requested that the benefits and the commitments contained within the Twinsburg Occupancy Program be assigned to Cellco Partnership d/b/a Verizon Wireless and Affiliates as the current owner and taxpayer.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Twinsburg, County of Summit and State of Ohio:

SECTION I: That the agreement pursuant to Resolution 165-2009, among Cellco Partnership d/b/a Verizon Wireless and Affiliates formerly known as Verizon Wireless, Summit County and City of Twinsburg, be and the same is hereby amended in all respects to change the identity of Verizon Wireless to Cellco Partnership d/b/a Verizon Wireless and Affiliates and as set forth in the form attached hereto and incorporated herein.

SECTION II: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were taken in an open meeting or meetings of this Council and any of its committees that resulted in such formal action, were in meetings open to the public and in full compliance with all legal requirements, including without limitation, those set forth in section 121.22 of the Ohio Revised Code.

SECTION III: That this Resolution shall take effect and be in force from and after the earliest period allowed by law.
