**RESOLUTION 51-2008**

A RESOLUTION AUTHORIZING THE CONTINUATION OF AN AGREEMENT WITH FIRST OFFICE SYSTEMS & SUPPLIES/SHRED-IT OF AKRON, 948 CHERRY STREET, KENT, OHIO 44240, TO PROVIDE TAX INCENTIVES UNDER THE TERMS AND CONDITIONS OF THE TWINSBURG OCCUPANCY PROGRAM CREATED BY ORDINANCE 144-2004

**WHEREAS**, the City of Twinsburg, by Ordinance 144-2004 has established the Twinsburg Occupancy Program to offer tax incentives to employers who created new jobs in the City of Twinsburg; and

**WHEREAS**, First Office Systems & Supplies/Shred-it of Akron has made application to the City of Twinsburg for certain tax incentives in the form of monetary grants as authorized under the terms and conditions of the Twinsburg Occupancy Program and such application was memorialized by way of an Agreement authorized by Resolution 130-2007 adopted November 15, 2007.

**WHEREAS**, The Duly appointed Twinsburg Tax Incentive Review Council for the Twinsburg Occupancy Program (TOP) has reviewed and recommends continuation of the Agreement for 2008.

**NOW, THEREFORE, BE IT RESOLVED** by the Council of the City of Twinsburg, County of Summit and State of Ohio:

**SECTION I:** That the Agreement with First Office Systems & Supplies/Shred-it of Akron, 948 Cherry Street, Kent, Ohio, 44240, providing certain tax incentives in the form of monetary grants not from tax revenues, at the percentage and for the term as stipulated in said agreement be continued for 2008.

**SECTION II:** It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were taken in an open meeting or meetings of this Council and any of its committees that resulted in such formal action, were in meetings open to the public and in full compliance with all legal requirements, including without limitation, those set forth in section 121.22 of the Ohio Revised Code.

**SECTION III:** That this Resolution shall take effect and be in force from and after the earliest period allowed by law.
