

**CITY OF TWINSBURG, OHIO**

**ORDINANCE 09-2005**

**AN ORDINANCE ABOLISHING THE PLANNING COMMITTEE OF COUNCIL AND DECLARING AN EMERGENCY**

**WHEREAS**, Section 7.01 Article VII of the charter of the City of Twinsburg authorizes Council to abolish certain boards or commissions; and

**WHEREAS**, the Planning Committee of Council is not presently an active committee; and

**WHEREAS**, Council, upon the concurrence of five members, has determined that it is appropriate to abolish the Planning Committee of Council.

**NOW, THEREFORE, BE IT ORDAINED** by the Council of the City of Twinsburg, County of Summit and State of Ohio:

**SECTION I:** That the Planning Committee of Council be and the same is hereby abolished.

**SECTION II:** That any and all ordinances and/or legislative enactments inconsistent herewith be and the same are hereby repealed.

**SECTION III:** It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were taken in an open meeting or meetings of this Council and any of its committees that resulted in such formal action, were in meetings open to the public and in full compliance with all legal requirements, including without limitation, those set forth in section 121.22 of the Ohio Revised Code.

**SECTION IV:** That this Ordinance is hereby declared to be an emergency measure, necessary for the immediate preservation of the public peace, health, safety, welfare and convenience of the citizens of the City of Twinsburg, and for the additional reason that it is necessary for the efficient operation of city government, and provided it receives the affirmative vote of five or more members of Council, it shall take effect and be in force immediately upon its passage and approval of the Mayor; otherwise, it shall take effect and be in force at the earliest period allowed by law.
