RESOLUTION 11-2005

**A RESOLUTION APPOINTING ONE MEMBER TO
THE CIVIL SERVICE COMMISSION AND
DECLARING AN EMERGENCY**

WHEREAS, Section 7.05 of the Charter of the City of Twinsburg provides that the Civil Service Commission shall consist of three (3) qualified electors of the City, not holding another City office or appointment; and

WHEREAS, the term of office of one member expires on January 31, 2005; and

WHEREAS, it is now incumbent upon this Council to appoint one qualified member to said Commission to fill such resulting vacancy upon said Commission.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Twinsburg, County of Summit and State of Ohio:

SECTION I: That the following named elector of the City of Twinsburg not holding any other municipal office or appointment be, and the same hereby is appointed as a member of the Twinsburg Civil Service Commission to serve the term as the same appears below:

1. Donald Spera	1-25-05 through 1-31-11

SECTION II: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were taken in open meeting or meetings of this Council, and that all deliberations of this Council were in meetings open to the public and in full compliance with all legal requirements, including without limitations, those set forth in Section 121.22 of the Ohio Revised Code.

SECTION III: That this Resolution is hereby declared to be an emergency measure, necessary for the immediate preservation of the public peace, health, safety welfare and convenience of the citizens of the City of Twinsburg, and for the additional reason to fill this vacancy prior to February 1, 2005, and provided it receives the affirmative vote of five or more members of Council, it shall take effect and be in force immediately upon its passage and approval of the Mayor; otherwise, it shall take effect and be in force at the earliest period allowed by law.
