ORDINANCE 09-2006

AN ORDINANCE ACCEPTING THE LANDS AND IMPROVEMENTS DEDICATED TO PUBLIC USE FOR COMMONS BOULEVARD AND DECLARING AN EMERGENCY

WHEREAS, the City Engineer has now recommended that the lands and improvements therein should be accepted for dedication to public use; and

WHEREAS, the Developer has agreed to prepare and record a roadway dedication plat to be filed with the Summit County Recorder.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Twinsburg, County of Summit and State of Ohio:

SECTION I: That the lands and improvements dedicated to public use upon the plat of The Commons as described in plans and drawings for said roadway on file with the City Engineer, be and the same hereby is accepted by the City of Twinsburg, Ohio.

SECTION II: That the Developer is directed to file with the County Recorder a Roadway Dedication Plat to be formally accepted by the City.

SECTION III: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were taken in open meeting or meetings of this Council, and that all deliberations of this Council were in meetings open to the public and in full compliance with all legal requirements, including without limitations, those set forth in Section 121.22 of the Ohio Revised Code.

SECTION IV: That this Ordinance is hereby declared to be an emergency measure, necessary for the immediate preservation of the public peace, health, safety, welfare and convenience of the citizens of the City of Twinsburg, and for the additional reason that it is necessary to complete this dedication, and provided it receives the affirmative vote of five or more members of Council, it shall take effect and be in force immediately upon its passage and approval of the Mayor; otherwise, it shall take effect and be in force at the earliest period allowed by law.
