ORDINANCE 37-2006

AN ORDINANCE AUTHORIZING THE PURCHASE OF THREE (3), 2006 DODGE CHARGERS THROUGH THE OHIO DEPARTMENT OF ADMINISTRATIVE SERVICES, OFFICE OF STATE PURCHASING, FOR USE BY THE POLICE DEPARTMENT OF THE CITY OF TWINSBURG, AND DECLARING AN EMERGENCY

WHEREAS, Resolution 17-1988 authorizes the Mayor of the City of Twinsburg to purchase certain equipment through the Ohio Department of Administrative Services, Office of State Purchasing, pursuant to Ohio Revised Code Section 125.04; and

WHEREAS, the purchase of certain equipment through said office is in compliance with the provisions of the Charter of the City of Twinsburg relative to competitive bidding; and

WHEREAS, Council is advised by the administration that it is necessary to acquire police cruisers for use by the Police Department.

NOW THEREFORE, BE IT ORDAINED by the Council of the City of Twinsburg, County of Summit and State of Ohio:

SECTION I: That the Mayor is hereby authorized to purchase through the Ohio Department of Administrative Services, Office of State Purchasing, from an authorized dealer, three (3) – 2006 Dodge Chargers at a total cost not to exceed the amount of SEVENTY THOUSAND THREE HUNDRED SEVENTY ONE AND 75/100 DOLLARS (\$70,371.75).

SECTION II: That the Director of Finance is hereby authorized to disburse the amount of Seventy Thousand Three Hundred Seventy One and 75/100 Dollars (\$70,371.75) from account number 10-050-5252-11 Police Equipment/Safety.

SECTION III: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were taken in open meeting or meetings of this Council, and that all deliberations of this Council were in meetings open to the public and in full compliance with all legal requirements, including without limitations, those set forth in Section 121.22 of the Ohio Revised Code.

SECTION IV: That this Ordinance is hereby declared to be an emergency measure, necessary for the immediate preservation of the public peace, health, safety welfare and convenience of the citizens of the City of Twinsburg, and for the additional reason to obtain the police cruiser as soon as possible, and provided it receives the affirmative vote of five or more members of Council, it shall take effect and be in force immediately upon its passage and approval of the Mayor; otherwise, it shall take effect and be in force at the earliest period allowed by law.
