**RESOLUTION 18-2007 AS AMENDED 1-23-07**

A RESOLUTION APPOINTING ONE RESIDENT MEMBER TO THE GLENEAGLES ADVISORY BOARD AND DECLARING AN EMERGENCY

**WHEREAS**, Section 153.02 of the Codified Ordinances of the City of Twinsburg provides that the GlenEagles Advisory Board shall include three citizen representatives of the City; and

**WHEREAS**, the term of office of one member expires January 31, 2007; and

**WHEREAS**, it is incumbent upon this Council to appoint one member to said Board.

**NOW, THEREFORE, BE IT RESOLVED** by the Council of the City of Twinsburg, County of Summit and State of Ohio:

**SECTION I:** That the following named inhabitant of the City of Twinsburg be and the same hereby is appointed as a member of the GlenEagles Advisory Board for the term as the same appears below:

**SECTION II:** It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were taken in open meeting or meetings of this Council, and that all deliberations of this Council were in meetings open to the public and in full compliance with all legal requirements, including without limitations, those set forth in Section 121.22 of the Ohio Revised Code.

**SECTION III:** That this Resolution is hereby declared to be an emergency measure, necessary for the immediate preservation of the public peace, health, safety welfare and convenience of the citizens of the City of Twinsburg, and for the additional reason to fill the vacancy on this Board as soon as possible, and provided it receives the affirmative vote of five or more members of Council, it shall take effect and be in force immediately upon its passage and approval of the Mayor; otherwise, it shall take effect and be in force at the earliest period allowed by law.


