PUBLIC PARTICIPATION:

Bob Thewes – 2229 Demi Drive

Mr. Thewes stated when the city was planning the Golf/Banquet center he warned them about spending money they did not have. He stated that we should have been looking at a reduction in city employees due to the history of overspending. Assuming the same people are in place after the elections, there will be no reduction in force but a .05% income tax increase to be put on the ballot. Additionally there will be an increase on the inside millage for target tax increases for Police and Fire Pensions without a vote of the people. City fees will continue to go up on everything. Garbage fees will be instituted, sewer fees will continue to go up, Fitness Center and Golf Course fees will increase also. Seniors on fixed incomes will start to move out of Twinsburg. Businesses will look to relocate.

Loren Sengstock – 2704 Arbor Glen #105

Mr. Sengstock spoke about the lack of fiscal discipline and how it will take years to overcome with the residents. He offered recommendations including a minimum fund balance policy, the mayor and council to address fiscal sustainability operating needs for all programs, performance audit for all the city departments and should prepare a 5 year budgetary forecast.

- Planning Commission met on 3/18. They discussed a Final Site Plan for Good Shepard Church and approved it. They talked about the rezoning on NE corner of Glenwood & SR91. 2 members are in favor of mixed use and 2 are in favor of R-5. Ms. Muter spoke to the commission about the 5G micro cell towers. The State of Ohio has put guidelines in place that limits the authority of any municipality. There are some design guidelines that the city can put in place. The next Planning Commission meeting will be 4/1 at 7:00 pm where new members will be sworn in.
- The Environmental Commission will has scheduled a MINI STREET CLEAN-UP on Highland Road from Route 91 to near Hadden Road and on Summit Street and 91 near the CVS building. Chris Campbell – Public Works Director

- **Roadway Maintenance** During the months of March and April to date a total of 133 pot holes were patched, bringing the season total to 2,274
- Animal Control Crews removed 11 dead animals from the streets. We will continue to work with A & S Animal Control for trapping etc.
- Storm Area Checks The collection areas were cleaned on March 13 with the April cleaning scheduled for today
- Microturbine The Wastewater department's microturbine continues to run well
- Snow and Ice Totals for the 2018-2019 season are: 19 events (25 last season); 2,481 tons of salt (7,170.5 tons last season); 36,700 gal of brine and 23,895 miles driven.
- Senior driveways were plowed on 4 occasions
- Legislation Ordinance 36-2019 is presented tonight to allow for purchasing of salt through the ODOT program for the 2019-2020 season
- **Building Renovations** All building renovation projects have been completed for the year including the relocation of a door at the Glen Eagles clubhouse
- Sewer System Repairs Performed a sanitary system repair at 9462 Hyde Park and completed the manhole installation on Waldo Way
- **Easter Egg Hunt** Completing preparations for the Easter Egg Hunt
- **Auction** The auction list has been completed
- Legislation- Ordinance 20-2019 is presented tonight for approval of the auction list. All items to be sold on GovDeals.com
- Branch Chipping The 2019 branch chipping season began on Monday, April 1 and concluded on Monday, April 8. A total of 115.5 cu yd. of debris was collected from 453 stops

- o Next Round The next round of chipping will begin on Monday, May 6
- Parks Maintenance Seasonal parks maintenance began with the following tasks:
 - -Playground mulch was applied under the equipment at Liberty and Belmeadow Parks
 - -Baseball and soccer field maintenance has been initiated
 - -Dead trees are being removed from the parks
 - -Trail clean-up has been initiated
- Litter Removal The initial round of litter removal was completed with a total of 24, 55 gallon bags of litter removed
- **Locust Grove Cemetery** 3 burials were performed

<u>Tim Morgan – Fire Chief</u>

Call Volume

• The fire department ran a total of 227 calls this March, for the year that is 697 calls, which down 6% compared to last year.

Notes

• There were no notable events last month

Fire Prevention

Inspected 22 locations and 2 fire investigations.

Training

- There were 28 hours of Public Education totally about 998 personal contacts
- Department logged 126 training events which was approximately 486 hours of training.

Points of Interest

- Weather Warning Sirens: April's monthly test of the system was conducted on the 6th and all sirens functioned properly, except for the indicator light at the Cannon Rd and Liberty Rd. site
- Firefighter Entrance Exam: Scheduled for April 27 Captains Promotional Exam: Being scheduled.

Russ Rodic – Building Commissioner

- Construction activity through Building Division for the month of February reported 47 applications for plan review with a construction value of \$623,294, field staff performed 119 inspections, and 13 point of sale applications were processed,
- Double pole update, Windstream has begun removal of the abandon poles, process of cutting at the grade level of the pole, began operation in the Glenwood acres subdivision,
- Building division is developing an electronic plan review process for applications limiting to roofing, siding, concrete, and window replacements of such work to be performed.

<u>Larry Finch – Community & Economic Development Director</u>

- 37-2019 Pepperl Fuchs CRA Agreement (pass over until May meeting to allow taxing authority review and comment prior to Council action). \$25 million investment in 50,000 s.f. new building near 8181 Darrow Road. 50% abatement for 12 years. Company will relocate 137 jobs from Twinsburg Twp. to City with \$9.7 million payroll.
- 38-2019 Continuation of CRA agreements for eight companies who are in compliance with the terms of their agreements as determined by the TIRC at their March 19 meeting.
- 39-2019 Continuation of TOP agreements for nine companies who are in compliance with the terms of their agreements as determined by the TIRC at their March 19 meeting.

- 40-2019 Termination of the TOP agreement for National Enterprise Systems. This company came to Twinsburg three years ago and benefitted from the TOP program but significantly reduce employment below the original numbers. This violated the TOP agreement. The TIRC recommended termination at their March 19th meeting.
- 41-2019 Termination of a CRA agreement with Ganzhorn Properties related to abatement for an addition put in place in 2012. The company has never been able to maintain the base employment. As a result the TIRC recommended termination of the agreement.

TCIC

- Next meeting is this Thursday (April 11th) at 6pm in the Jury Room.
- All financial info requested by the Auditors for this year's report have been provided and no current issues have been cited.

Downtown Redevelopment District

- A draft ordinance creating the DRD has been developed and forwarded to the Mayor and Law Director for preliminary review.
- We continue to work on the Economic Development Plan for the DRD. A draft should be completed by mid-May.
- The Mayor and I will be meeting with central area property owners to explain the DRD and its benefits.

Chris Noga – Police Chief

- During the month of March the City of Twinsburg Communications Center generated 2,530 calls for service among the Twinsburg Police and Fire Departments and the Reminderville Police and Fire Departments. The total for the year is 7,434.
- Twinsburg police officers arrested and/or cited 146 suspects into court on 230 different counts. The arrest counts include: (2) counts of Aggravated Robbery w/gun (felony), (24) Drug related charges, (5) Liquor possession/Open container charges, (25) for Driving under suspension or without a valid license, (24) Operating a vehicle under the influence of alcohol and/or drugs of abuse charges, (3) Domestic violence charges, (14) Warrants served, (2) counts of Obstructing official business, (2) Aggravated menacing, and (3) counts of Complicity. The remaining charges were various other criminal or traffic related charges.
- Twinsburg officers issued 222 written warnings and 3 parking citations.
- Officers investigated 37 traffic crashes of which 13 were injury crashes, 8 were on private property, and none were fatal.
- Reminded residents with the nice weather coming to slow down and drive safe.

Sarah Buccigross - Finance Director

- Finance is continuing to work with the Auditor of State Performance Audit team to scope and price the Performance Audit. Nicole Bent, presenter from last year, checked in last week to let us know that our scope proposal is currently under review with their leadership.
- Interest earnings YTD are \$66,965.46. This is an increase of 8% over the interest earnings at April 30, 2019 of \$61,820.99.
- The GAAP conversion process is underway. The auditors are scheduled to be on site on May 30th & 31st.
